Dear Gordon,

I want to express my thanks to The Greenspan Co. /Adjusters International and your team for the tremendous results you accomplished in the recovery of our insurance claim. We are extremely satisfied with our decision. Bruce Tibert, your lead adjuster, took command of our claim and negotiations with our insurance carrier and has returned more than three times what the initial claim value appeared to be.

This was a tragic loss for our company in that a private contract employee was lost in the explosion and with the total loss of our packing facility; we were concerned about losing our garlic season as well.

In the days that followed, I realized it would be impossible for me to try and maintain my normal workload and to devote the time needed to develop the claim properly. Gregg explained how we could go about obtaining a full recovery of our business and not lose our packing season.
